- 4. It was proposed by Richard Skirving and seconded by John Handley that the Minutes of Council Meeting held on 19 October 2021 were a true record and it was approved *nem com*.
- 5. Matters arising from these Minutes: none were received.
- 6. The adoption of the Annual Report of the Association was proposed by Colin Booth and seconded by Jan Annan and approved *nem con*.
- 7. The Treasurer made the following comments:
  - 1. £22K related to Crystal Palace hire fees not requested will now be brought into the accounts
  - 2. The return to the back-to-the-pool post-Covid grant had been well-received
  - 3. A Coach bursary scheme was to be introduced to support SwimMark and Stronger Affiliation requirements.

Although not advised in advance, Jan Annan asked that she could pose a financial question: What was the County's policy on supporting club funding for Ukrainian Refugees. She was advised that KCASA was following the Swim England protocols but would not be using the Kent levy. The question of other groups who might need hardship support was raised. Jan Annan said that she would be happy to submit suggestions at a later date.

The adoption of the Annual Accounts of the Association was proposed by Stewart Brown and seconded by Erica Moo and approved *nem con*.

- 8. The Appointment of the Examiners of the Association's Accounts: Perrys Accountants Limited on the recommendation of the Treasurer, was proposed by Barbara Upton and seconded by Richard Skirving and approved *nem con*.
- 9. Proposed amendments to the Constitution of the Association

Proposal 1: That the Constitution is amended as follows:

1. Name: The Association shall be called the Kent County Amateur Swimming Association ('the Association') and this formal name shall appear on all official correspondence, although the KCASA Management Committee may approve a different 'trading' name or names.

Proposal 2: Minor tweaks be made to the Constitution to reflect the change in name of the ASA to Swim England
